I am proud to introduce the inaugural Sponsored Research Report of the Office of Grants and Sponsored Research. The publication of this report is a reflection of the growth and maturation of TCNJ's efforts in securing external funding for research and other programs. Over the last 10 years, our faculty and staff have brought to the college over \$65,000,000. In this present report, you will find that during 2017 we submitted 110 new proposals and received \$7,397,197 in external funding. I congratulate our faculty and staff on their outstanding achievements in securing external funding and express my full support to their future efforts in this area.

A MESSAGE FROM THE EXECUTIVE DIRECTOR

Sponsored Research at The College of New Jersey advances scholarship, research, and service through the acquisition and management of extramural funding from federal, state, corporate, and private sources. Grants and Sponsored Research staff foster faculty and staff *engagement* through hosting interdisciplinary forums, where faculty learn about each other's research and research interests, workshops presented by the Grants Resource Center, to inform of federal trends in funding, resources, and best practices in developing fundable grant proposals, and information sessions covering regulatory compliance issues such as Federal Uniform Guidance requirements.

With the future implementation of a new web-based proposal tracking system, eProposal by iRIS, enhanced *efficiency* with proposal reviews, approvals, compliance, and data management will occur. The new eProposal system will be integrated with the new IRB online tracking system, enabling synchronized completion of IRB applications and grant proposal submissions for research involving human subjects. In addition, faculty and staff have access to the Collaborative Institutional Training Initiative (CITI) website, which offers quality, peer-reviewed, web-based educational courses in research, ethics, regulatory oversight, and responsible conduct of research training.

The College of New Jersey continues to successfully obtain external support for faculty research and interinstitutional/community collaborative research and projects. The institution receives an average of 52 grants/ year totaling on average \$7,937,902/year. These awards enhance student life and promote *excellence* in scholarship and innovation. The Office of Student Affairs, for example, received a multi-year grant from the U.S. Department of Justice, Office on Violence Against Women, to support a program that reduces sexual assault, dating violence, and stalking on campus.

This report highlights the acquisition of extramural support at The College of New Jersey over the last three years. I am excited to share the successes of our faculty and staff. **7**





AWARDS BY UNIT







